

THE VILLAGE AT CORRIMAL SUMMER CAMPAIGN Terms and Conditions

Promotion

1. These terms and conditions are for The Village at Corrimal Summer Campaign (Promotion)
2. This promotion is run by The Village Building Co. (Promoter/Seller)
3. The promotion applies to any Apartment or Villa nominated by the Promoter in The Village at Corrimal at the commencement of or during the promotion (Eligible Product). The Promoter reserves the right to withdraw any Eligible Product from sale and/or from the Promotion at any time or substitute any lot without notice. Each Eligible Product does not include any Apartment or Villa on which exist completed homes.

Promotion Bonus

4. A Promotion Bonus will be offered to the first 10 Eligible Buyers who purchase at The Village at Corrimal within the promotion period set out in paragraph 10 and 11 below.
5. The Promotion Bonus is valued at \$20,000 (incl. gst) and provides a choice of one of the packages set out below.
 - a. Package A – select upgrades to inclusions, fixtures and fittings to your Apartment or Villa from The Village at Corrimal product list. These will be selected post contract exchange.
 - b. Package B – the Promoter/Seller will pay the buyer's stamp duty & body corporate fees (limited to 12months). This will be paid upon providing the appropriate invoice/s (from Revenue NSW and the managing body corporate agent) to the Promoter/Seller at the time of charge.
 - c. Package C – a Hello World Travel Voucher inclusive of required comprehensive travel insurance and the terms and conditions as set out in the Hello World Travel Voucher. The Eligible Person will receive the Travel Voucher within 30 days of contract exchange.
6. The Promotion Bonus is personal to the recipient and cannot be transferred or assigned to any other party.

Promotion Period

7. The Promotion is available to an Eligible Buyer of an Eligible Product at The Village at Corrimal The earlier of:
 - a. 28 February 2019; or
 - b. 10 Eligible Buyers have purchased an Eligible Product.
8. The Promotion starts at 10.00am Wednesday 26 December 2018 and ends at 5.00pm Thursday 28 February 2019, subject to clause 7 above or unless cancelled by the Promoter in its absolute discretion.

Eligibility

9. Natural persons and private buyers (Eligible Buyer) are eligible to receive the Promotion Bonus. Companies and registered builders are not eligible to receive the Bonus.
10. The first 10 Eligible Buyers who during the Promotion Period enter into a contract for the purchase of an Eligible Product will receive the Promotion Bonus.

General

11. The Promotion is subject to any other terms and conditions set out in the sale contract.
12. The Promotion may be withdrawn, or these terms and conditions amended, at any time after the commencement of the Promotion.
13. The Promotion cannot be used in conjunction with any other promotion or offer relating to an Eligible Lot.
