

SPRING INTO VILLAGE COMPETITION Terms and Conditions

Promotion

1. These terms and conditions are for the **Spring into Village** Competition (Promotion).

Promotion Period

4. The Promotion starts at 6.00pm AEST on Tuesday 8th September 2020 and ends at 5.00pm AEST on Tuesday 22nd September 2020 (Promotion Period).

How to Enter / Eligibility

To enter via Facebook:

5. The entrant must be following the @VillageBuildingco page on Facebook.
6. The entrant must comment on the competition post with their photograph.
7. The entrant must share the competition post.
8. Each comment with a photograph will be deemed as one entry.
9. Entrants may enter multiple times.

To enter via Instagram:

10. The entrant must be following the @VillageBuildingco page on Instagram.
11. The entrant must share a photograph to their account and use the hashtag #springintovillage. Entrants pages must be set to public to be eligible for entry.
12. Each photograph will be deemed as one entry.
13. Entrants may enter multiple times.

Prize

14. There will be five (5) winners chosen and each will each receive one (1) prize.
