

## THE VILLAGE CHRISTMAS SPARKLE COMPETITION Terms and Conditions

### Promotion

1. These terms and conditions are for the Village Christmas Sparkle Competition (Promotion).
2. This promotion is run by Village Building Co ABN: 97 056 509 025 (Promoter/Seller).
3. The competition is open to residents of Australia except employees of Village Building Co and their close relatives and anyone otherwise connected with the organisation or judging of the competition.

### Promotion Period

4. The Promotion starts at 6.00am AEST on Friday 27<sup>th</sup> November 2020 and ends at 5.00pm AEST Monday 14<sup>th</sup> December 2020 (Promotion Period).

### How to Enter / Eligibility

#### *To enter via Facebook:*

5. The entrant must be following the @VillageBuildingco page on Facebook.
6. The entrant must comment on the competition post with a photograph of their own Christmas tree.
7. Each comment with a photograph will be deemed as an entry.
8. Only one entry per person.
9. If a person enters more than once, only the first entry will be judged

#### *To enter via Instagram:*

10. The entrant must be following the @VillageBuildingco page on Instagram.
11. The entrant must share a photograph of their own Christmas tree to their account and use the hashtag #villagechristmassparkle. Entrants pages must be set to public to be eligible for entry.
12. Each photograph will be deemed as one entry.
13. Only one entry per person.
14. If a person enters more than once, only the first entry will be judged

### Prize

15. There will be five (5) winners chosen and each will each receive one (1) prize.
